

School Facilities Fee Certification of Compliance/Application

Notice to Applicant

This fee is collected pursuant to Education Code Section 17620, et al., on all square footage of residential floor area, and on all square footage of commercial/industrial covered and enclosed space (less roof overhangs) per floor, including mezzanines. Instruments returned for non-sufficient funds are subject to a bank fee; applicable projects will not receive a final inspection or certificate of occupancy until the instrument is redeemed. When properly certified by the school district, this application becomes your Certification of Compliance. If a project is located in both an elementary and high school district, a separate Certification of Compliance is required from each school district.

Procedure for Payment of School Facilities Fee

1. Applicant applies to the local permit issuing jurisdiction (city or county) for a building permit.
2. Applicant submits school facilities fee application form showing calculated square footage to the respective school district.
3. Upon payment of the school facilities fee, the applicant will be provided with an executed copy of the Certification of Compliance.
4. Applicant must file the executed Certification of Compliance with the local permit issuing jurisdiction (city or county) to obtain a building permit.
