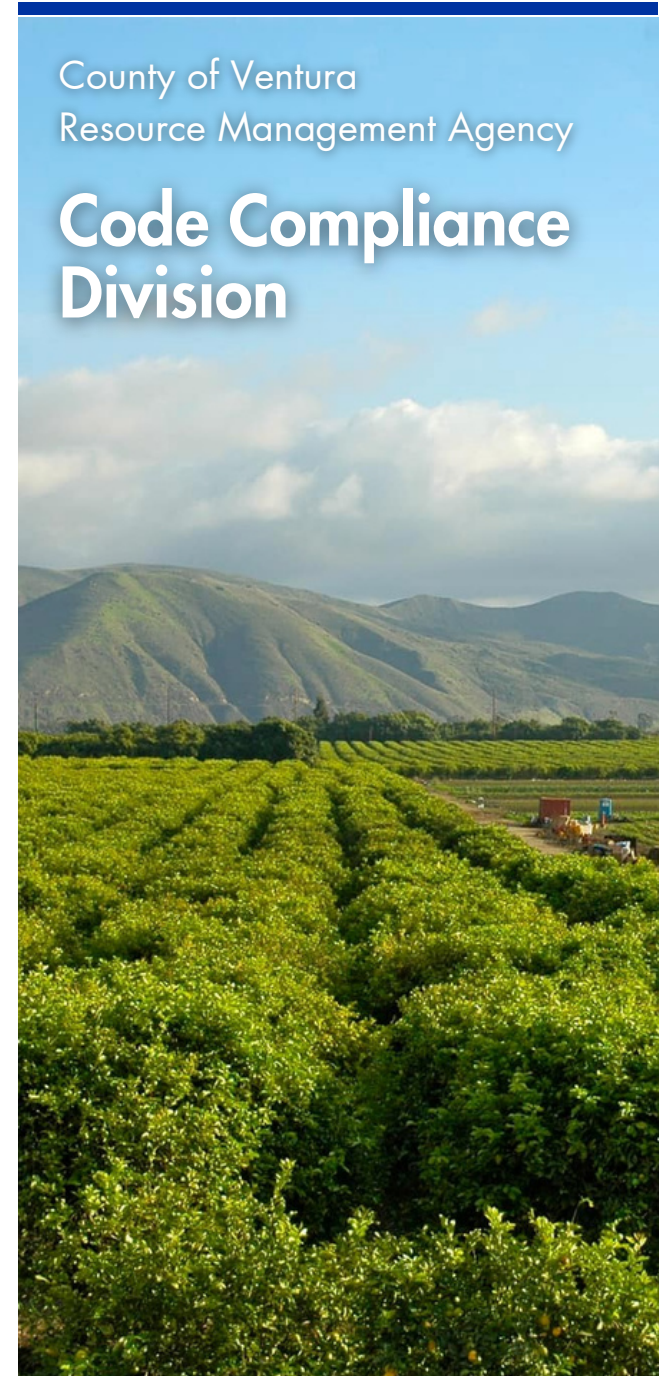

What do Code Enforcement Officers Do?

Staff respond to complaints, investigate violations, and assist property owners in resolving issues such as unpermitted construction or unsafe conditions. Through education and enforcement, the Division promotes safe, well-maintained neighborhoods across the County.

Examples of Code Violations

- Outdoor storage of inoperative motor vehicles, campers, boats, trailers, etc.
- Outdoor storage of items on property and/or within required setbacks.
- Unpermitted buildings or construction.
- Unlawful grading or brush removal.
- Fences exceeding maximum height limits.
- Illegal dwelling or living in recreational vehicles
- Trimming/removal of protected trees without permits or construction within a protected tree zone.
- Activities related to a commercial or industrial use without the proper permits.
- Keeping excessive pets or farm animals.
