Publication of Notice for Modified Solid Waste Facility Permit Application

In compliance with Title 27 California Code of Regulations (27 CCR), Section 21660.3, the Environmental Health Division (Division) acting as the Local Enforcement Agency (LEA), and the applicant (operator), shall notice within 60 days of receipt of an application for modified solid waste facility permit (SWFP), and post for at least ten (10) days, a temporary public notice of the proposed modification to the SWFP.

Description of Proposed Changes

1. Remove the daily tonnage cap of 8,000 tons per day (TPD) of MSW and recyclables from SWFP Section 17(B)(5). The facility's maximum permitted daily tonnage of 12,000 TPD and maximum weekly average of 64,750 tons per week, remain unchanged. The facility's current Conditional Use Permit (CUP) and environmental documents (Final Environmental Impact Report) do not include the 8,000 TPD cap.
2. Restore the maximum elevation of 1,275 ft. mean sea level to SWFP Section 4(e).
3. Update the estimated closure year in SWFP Section 4(e) from 2063 to November 2056 based on a change in Airspace Utilization Factor (tons of waste per cubic yard of landfill airspace) from 1.2 million tons to 1.1 million tons and an anticipated increase in annual tonnage from 2.3 million tons to 2.4 million tons per year.



4. Update applicable sections of the Joint Technical Document (JTD), including Tables and Figures to reflect current cost estimates of closure and Water and Non-Water Release Corrective Action Plans, and Financial Assurances, and current topographical maps.
5. Update applicable sections of the JTD to reflect current design and operations, including the addition of the Renewable Natural Gas Facility and ancillary structures, addition of a third flare, and updates to the Landfill Gas (LFG) collection system and perimeter monitoring network.

LEA Findings

The Division's preliminary determination is the proposed changes require modification of the SWFP with the following findings:

1. The proposed changes are consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents for SVLRC;
2. The proposed changes are acceptable and consistent with, but not limited to, State minimum standards in 27 CCR;
3. The proposed changes do not conflict with the terms and conditions in the current SWFP;
4. The proposed changes to modify the SWFP are non-material changes as specified in 27 CCR, Section 21563(d)(5).
