Consider Point of Interest Designation for Historic Property

The Ventura County Cultural Heritage Board (CHB) will consider designation of property as Ventura County Point of Interest No. 16, in accordance with Section (1365-1) et seq. of the Ventura County Ordinance No. 4604. The property is the site of the former Day Ranch House, historically important as a former distinctive example of an Italianate-style residence and reflective of Ventura County's agricultural history due its over one-hundred-year association with agriculture and early Ventura pioneer James Day. The property is located at the following address:

You are hereby notified of a public hearing to be held before the CHB to review this consideration. At this hearing, there may be presentations by the applicant, the property owner, and staff with an opportunity for any interested person or authorized agent to comment on the item.

The CHB is the final decision-making authority on the Point of Interest designation where the property owner has no objection.
