Consider Point of Interest Designation for Historic Property

The Ventura County Cultural Heritage Board (CHB) will consider designation of property as Ventura County Point of Interest No. 17, in accordance with Section (1365-1) et seq. of Ventura County Ordinance No. 4604. The property is the site of the original Oliveland School, historically important as an early segregated school for Mexican farmworker children and for its later desegregation as part of the region's broader civil rights progress, as well as for its 1924 expansion by Roy C. Wilson, Ventura County's first licensed architect. The property is located at the following address:

You are hereby notified of a public hearing to be held before the CHB to review this consideration. At this hearing, there may be presentations by the applicant, the property owner, and staff with an opportunity for any interested person or authorized agent to comment on the item.

Environmental Review: This application is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15308 which is consistent with a Class 8 exemption (Actions by Regulatory Agencies for Protection of the Environment).

Notice is hereby given that the County Ordinance Code authorizes the CHB to designate the above property as a Ventura County Point of Interest once a notice is given to the property owner and a public hearing is held on the matter. The CHB is the final decision-making authority on the Point of Interest designation where the property owner has no objection.
