REGARDING UPDATES TO REGULATIONS FOR ACCESSORY DWELLING UNITS AND JUNIOR **ACCESSORY DWELLING UNITS (CASE NO. PL25-0037)**

APPLICANT: County of Ventura

PROJECT LOCATION: All coastal parcels in the unincorporated County zoned: Coastal Rural (CR); Coastal Rural Exclusive (CRE); Coastal One-Family Residential (CR1); Coastal Two-Family Residential (CR2); Residential Beach (RB); Residential Beach Harbor (RBH); Coastal Residential Planned Development (CRPD); Coastal Open Space (COS); and Coastal Agricultural (CA).

PROJECT SUMMARY: The project consists of a County-initiated ordinance to amend Articles 2, 4, 5, 6, and 11 of the Ventura County Coastal Zoning Ordinance to update regulations and development standards for Accessory Dwelling Units (ADUs) and to add regulations and development standards for Junior Accessory Dwelling Units (JADUs), consistent with Government Code Section 66310 et seg. The amendments also include minor revisions to Article 5 to remove outdated references to mobilehomes and clarify requirements for wet bars.

DOCUMENT AVAILABILITY: Pursuant to California Code of Regulations, Title 14, CR 13515(a)(c), the proposed Coastal Zoning Ordinance amendment and the policy consistency analysis with the Coastal Act and Local Coastal Program (LCP) can be viewed on the Planning Division website at https://rma.venturacounty.gov/divisions/planning/accessory-dwelling-units/#coastal-zone.
