WHEREAS, the County of Ventura has by said ordinance en cowered the Ventura County Cultural Heritage Board to evaluate historical sites, hold public hearings, make recommendations, maintain a current list of all historic, cultural and natural landmarks and monuments, adopt additional rules and regulations, and take steps necessary to preserve such landmarks and monuments; and

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Ventura County Cultural Heritage Board is hereby designated as the Cultural Heritage Board of the City of Fillmore;

- 2. The Ventura County Cultural Heritage Board shall have all rights, powers, duties and obligations in the City of Fillmore as granted by the City in Ventura County Ordinance No. 2737, and said ordinance is hereby adopted and herein incorporated by reference as though set forth in full;
- 3. With respect to those sites recommended by the Ventura County Cultural Heritage Board that are located within the City limits of Fillmore, the Fillmore City Council shall have all rights, powers, duties, obligations and final approval as granted to the County Board of Supervisors by Ventura County Ordinance No. 2737, and all reference made to the Ventura County Board of Supervisors in said ordinance shall be to the City Council of the City of Fillmore.
